



Develop your Corporate Plan

Define and allocate your group's corporate initial objectives.

The first step is to **identify and mark** sustainable initiatives and efforts that apply to all business units, as they are **actions implemented at the corporate level** for the whole chain, on basic sustainability issues. Let's look at some examples:

- « Have non-discriminatory hiring policies »
- « Enable digital channels for transparent internal and external communication »
- « Have digital interdepartmental communication mechanisms »

Provide corporate evidence in 1 single step

As you map your group's common activities to your corporate plan (as sustainable activities to be carried out in all business units), you will be able to demonstrate how they are carried out in all business units, providing corporate evidence to validate compliance. **A process you will only have to go through once:**

- In just one click, apply corporate evidence to the sustainability plans of several or all the entities in your group: work on several plans in a single process.
- Manage corporate information centrally and in a single step.
- Simplify work times and make your certification more efficient.

Invite as many users as you need without limit.

Give access and permissions to an unlimited number of users at no additional cost. Depending on your role and functions in the sustainability strategy, you may have permissions to monitor the overall sustainability of the group as a whole, and / or permissions to work on the sustainability plans of one, several or all business units.



Individual sustainability plan for each entity

Each entity of the group will have its **own profile and action plan by SDG and sustainability area (ESG)**. he individual plan of each business unit will be based on the common corporate plan, previously developed by the chain's corporate plan. Thus, all the group's entities will work on **common objectives and initiatives**, and the process will be much simpler for them, as it will have been previously advanced from the head office.


Allows the most appropriate people to contribute the **specific information of each business unit in their respective individual sustainability plans**. As each business unit works on its own corporate sustainability plan, the certification process is carried out independently for each entity, with each establishment holding its own certificate after passing its audit.

- More dynamic and faster for all your business units.
- A true **multi-site system** for centralising information.
- Global but at the same time **individual and personal** for each entity of the group.
- Keeping the **particularities of each establishment** to enhance the value of its certification and its recognised efforts.

Process completed in 3 months or less!

The duration of the entire certification process will depend on the time it takes for the company's team to upload its information and evidence on the Biosphere® platform; provided that the sustainable efforts of the group and the entity in question cover the 17 Sustainable Development Goals, at the minimum required by the Biosphere® standard, for a balance between the ESG areas.

With a maximum of 15 working days for an initial online evaluation of Starters initiatives, and 25 working days for the 100% online external audit process, the business unit **can achieve its certification in a record time of 3 months!**

Communicate your corporate sustainability centrally



Why Biosphere?


The Biosphere[®] methodology, created by the **Responsible Tourism Institute (RTI)**, provides a unified, global and international system to collect, analyze and visualize company progress and sustainable efforts by **SDG and ESG sustainability field**, facilitating data-driven decision-making and promoting the adoption of sustainable practices.

Pioneers and harmonisers

Biosphere[®] was the first system in the world to **incorporate socio-cultural aspects**, as well as environmental and economic aspects, in sustainability management and certification processes. It was also the **first sustainability methodology to certify sustainability in its three ESG areas** - environment and climate change; society and culture; governance and economy - in the hotel sector (since 1997). The criteria of the Biosphere[®] methodology since 1997 **set the basis and precedent** for the creation, in 2010, of the global criteria of the Global Sustainable Tourism Council (GSTC), along with others.

Years later, the 2015 United Nations guidelines on sustainability led to the close collaboration of RTI with UN-SDSN [Sustainable Development Solutions Network] to adopt the 17 Sustainable Development Goals, 169 targets and UN indicators in the Biosphere[®] methodology, making it the first and only certification in the world that allows tourism's contribution to the 2030 Agenda and the 17 UN SDGs to be assessed.

Currently, **Biosphere® is a founding member of the TSCA**, an international alliance of sustainability certification bodies for the tourism industry, whose criteria serve as a **basis and harmonised standard worldwide**. Biosphere® certification is also valid for national sustainability programmes such as **Swisstainable** or **Sustainable Travel Finland**, among others, and sustainable label monitoring systems such as **Travalyst**.

The Biosphere[®] methodology and platform makes working on sustainability strategies and plans **quick and easy for all staff,** inviting **cross-departmental collaboration**, regardless of whether they have never used it or have done other certification processes and systems before.

Its **language and functions simplify the processes** for identifying the organisation's good practices, as well as for demonstrating them in **100% online external audit processes**. And as Biosphere[®] criteria **cover all international sustainability standards,** under the framework of the **17 SDGs and 169 UN targets**, creating and demonstrating your sustainable initiatives for any responsible declaration with Biosphere[®] is easier, **more centralised and global** than ever, with criteria:

- Standardised according to **TSCA (Tourism Sustainability Certifications Alliance)** guidelines, in compliance with European and national directives.
- Viable, scalable and adapted to the reality of your company, according to your typology, size, resources and outreach capacity.
- You can even create and recognise your own innovative and pioneering initiatives, and share them with the rest of the members!


